## **Limited One-Year Parts Warranty**

**PetroVac - Vacuum Pump System (Patent Pending)**

### **1. WARRANTY COVERAGE**

Petro Specialties, Inc. ("Warrantor") warrants to the original purchaser ("Customer") that the PetroVac Vacuum Pump System ("Product") will be free from defects in materials and workmanship in the covered parts, under normal use and service, for a period of **one (1) year** from the date of purchase.

**This Limited Warranty covers only the repair or replacement of defective parts. Labor, travel, removal, installation, diagnostics, shipping, and any other associated costs are expressly excluded.**

### **2. WHAT IS COVERED**

- Only parts assembled or manufactured by Petro Specialties, Inc. found to be defective in material or workmanship.
- Replacement or repair of such defective parts, at the sole discretion of Petro Specialties, Inc.

### **3. WHAT IS NOT COVERED**

This Limited Warranty does **not** cover:

- Labor charges for removal, installation, diagnostics, or service
- Routine maintenance, consumables, expendable items, or normal wear and tear
- Damage caused by improper installation, misuse, neglect, accident, unauthorized modification or repair, operation outside published specifications, or acts of nature
- Damage resulting from failure to follow the Installation and O&M Manuals

- Components or accessories not supplied by Petro Specialties, Inc. (such items are subject only to the original manufacturer's warranty, if any)
- Any costs related to transportation, shipping, or handling of parts

#### **4. DURATION AND LIMITATION ON IMPLIED WARRANTIES**

This Limited Warranty is valid for **one (1) year** from the date of installation. Any implied warranties, including those of merchantability or fitness for a particular purpose, are limited in duration to the term of this written warranty, to the extent permitted by law.

#### **5. HOW TO MAKE A WARRANTY CLAIM**

To obtain warranty parts or service, Customer must:

1. Notify Petro Specialties, Inc. in writing within the warranty period and within thirty (30) days of discovering the defect.
2. Provide the Product model and serial number, date of installation, description of the issue, and proof of purchase/installation.
3. Return the defective part(s), freight prepaid, to Petro Specialties, Inc. or as directed. Repaired or replacement parts will be shipped ground freight prepaid within the continental United States.
